The Open and Closed Minutes for the November 27, 2024 Authority Meeting were emailed to the Commissioners for their review.

b. <u>Wastewater Program</u>

Superintendent's Report

Mr. Phillips reported that the Annual Inspection for the Paulinskill Wastewater Reclamation Facility was conducted by the NJDEP; there were no issues. The Plant is in compliance and running smoothly.

Executive Director's Report

Mr. Sesto reported that the SCMUA is a member of the New Jersey Sewerage and Municipal Utility Authority Electrical Supply Aggregation ("NJSMUAESA") which allows SCMUA to benefit from bulk electricity purchasing. The next bid opening is scheduled for February 25, 2025. A resolution has been prepared to authorize the Executive Director or Comptroller to approval award a contract for electric supply to the low bidder the same day as the bid opening. Commissioner Drake moved the authorizing resolution, seconded by Commissioner Madsen, on roll call: Ayes (9) Commissioners Meyer, Madsen, Cocula, Dietz, Petillo, Drake, Finkeldie, Wesley, Poggi; Nays (0); Abstain (0). The resolution passed.

Watershed Director's Report

Mr. Sajdak reported on the recent closing of the sale of the former Culver Lake Golf Course to the Greater Culver Lake Watershed Conservation Foundation. The acquisition allows the SCMUA – WRWMG to begin the restoration project grant from the National Fish and Wildlife Foundation. The funding was also secured to purchase four (4) floating treatment islands for the pond on the property, an educational kiosk and sign, and materials for a wildlife viewing platform.

Comptroller's Report

Mr. Day reported on the Septage, Sludge and Hauled Sewage Revenues for December 2024, the first month of FY2025. Septage volumes were at 5% of annual projections, Sludge volumes were at 5% of annual projections, and Hauled Sewage volumes were at 7% of annual projections. All were slightly below anticipated totals for the month. For

December, the connection fees collected for the Upper Wallkill Plant were \$103,053.00 and the Paulinskill Facility had no new connections.

c. <u>Solid Waste Program</u>

Superintendent's Report

Superintendent Morris reported on the recently purchased BOMAG Landfill Compactor. The staff was trained on operation and maintenance for the equipment, and it is currently in service. The SCMUA's compactor trade-in was accepted by the vendor and is scheduled for pick up.

Mr. Morris reported on the annual collection data for Solid Waste and Recyclable Materials. Total Solid Waste Tonnage was 109,303 tons for 2024, and recyclable material collected totaled 4,288 tons which was 2% higher compared to last year. There was in increase in liquid collection at the Recycling Center totaling 25,463 gallons. The paper shred events generated 41 tons of recyclable paper, and 48.64 tons of electronics were collected. The Household Hazardous Waste Events collected 28 tons for disposal off site. Mr. Morris then reviewed vehicle data. In 2024, 120,921 vehicles came in over the truck scales which represents an increase of 7.57% from last year. For 2024, the Bagged Garbage Area serviced 79,912 vehicles, and 51,940 vehicles utilized the Recycling Center.

Mr. Morris reviewed a resolution for the authorization of shared services agreements for municipalities that do not have a Certified Recycling Coordinator on staff to certify the 2024 Recycling Reports for submittal to the NJDEP. SCMUA Recycling Coordinator Dawn Latincsics provides the certification to those municipalities in need of this service. Commissioner Cocula moved the resolution, seconded by Commissioner Finkeldie. On roll call: Ayes (9) Commissioners Meyer, Madsen, Cocula, Dietz, Petillo, Drake, Wesley, Finkeldie, Poggi; Nays (0); Abstain (0). The resolution passed.

Executive Director's Report

Mr. Sesto gave a status report on the North Cap Construction Project. He indicated that the contractor is back on-site after the holiday break as of Monday morning. Tomco and ALCO Lining Company are working together to install the rain flap along the northeast project area.

Comptroller's Report

Mr. Day reviewed the tonnages and revenues for December 2024, the first month of FY2025 for the Solid Waste Facility. Tonnage was up 3.9% compared to last year. Revenues for December 2024 totaled \$20,000 or 2.4% of annual revenue.
