Bidders are directed to submit one (1) original and one (1) copy of bid. Bidders are required to comply with the requirements of <u>N.J.S.A</u>. 10:5-31 et seq. and N.J.A.C. 17:27 et seq. Bidders are also required to comply with the requirements of Public Laws 1977, Chapter 33.

Bidders are solely responsible for the timely delivery of the bids and no bids shall be considered which are presented after the public call for receiving bids. The Authority will not assume responsibility for bids forwarded by mail or delivery services. Any bid received after the date and time specified will be returned, unopened, to the bidder.

The provisions of the New Jersey Local Public Contracts Law, <u>N.J.S.A</u>. 40A:11-1 et seq. are incorporated herein by reference. If the Contract is to be awarded, the SCMUA will award to
